



## END-USER SOFTWARE LICENSE AGREEMENT ("EUSLA")

### Applicable To Unifire AB Software, including FlameRanger, ONE App & Ammolite

This Unifire AB End User License Agreement ("License") describes the terms and conditions which apply to your use of any and all Unifire software, including but not limited to Ammolite, FlameRanger, ONE app, and related services and documentation ("Software").

Please note that this License is a legally binding agreement between you and Unifire AB ("Unifire"), and by using this Software, you agree to be bound by this License. If you do not agree with the License, please discontinue using the Software.

Also note that this License is subject to revision by Unifire from time-to-time and that your continued use of the Software will be subject to any such terms and conditions revisions. Accordingly, please review the License periodically (which is available on Unifire's website at <http://www.Unifire.com/eula>) to ensure that you are familiar with any revisions and that they are acceptable to you.

#### 1. Grant of Limited License.

Subject to the terms and conditions of this License, Unifire hereby grants to you a non-exclusive, non-transferable, non-sublicenseable, personal and limited license solely to use the Software on a single Unifire TARGA programmable logic controller ("PLC").

#### 2. Restrictions on Limited License.

Please note that this License does not authorize you to use the Software in any manner other than as expressly set forth in this License. You also specifically agree to not:

- use the Software or any Content for any commercial purpose.
- copy, decompile, reverse engineer, disassemble, attempt to derive the source code of, decrypt, modify, or create derivative works of, or otherwise deconstruct the Software, except to the extent expressly mandated by applicable law or to the extent as may be permitted by the licensing terms governing use of open-sourced components included with the Software or as authorized by Unifire's prior written agreement.
- modify, rent, lease, loan, sublicense, distribute, transmit, share (over a network or otherwise) or create derivative works based upon, the Software, or assign or otherwise transfer your rights under this License, except pursuant to a Unifire Distribution License Agreement executed by Unifire.
- disable, uninstall or otherwise impair the functionality of the Software, in whole or in part.

#### 3. Updates.

To ensure a consistent and high quality experience, Unifire may, from time to time, provide software updates and patches and you agree to follow Unifire's instructions on updating such software and/or grant Unifire and its agents permission and access to perform updates. Unifire reserves all rights not expressly granted to you, including without limitation copyright and other intellectual property rights. Unifire's licensors and suppliers are intended third party beneficiaries of this License and have the express right to rely upon and directly enforce its terms.

Unifire warrants to you that the Software will be uncorrupted when you receive it. If any portion of the Software is corrupted when you receive it, your exclusive remedy, and Unifire's entire liability in contract, tort, or otherwise, will be to use commercially reasonable efforts to provide uncorrupted Software to you.
